**SUMMARY:** Rubibi seek Shire advice and Council approval for suitably nominated people to become Honorary Shire Rangers, and through the Shire seek State Government Gazettal.

### BACKGROUND

Traditional Owners and more recently Minyirr Park staff have carried out an 'eyes on the ground' management role positively guiding and advising visitors to the coastal areas. They are however concerned about the illegal activities such as fire, rubbish dumping, dog control, motorbike and vehicle impacts and quarantine issues like introduced weeds.

These people are in a unique position to undertake the role of Honorary Rangers for the Shire of Broome, to help care for country and to assist the Shire with their Ranger responsibilities.

*We now wish to submit these names as responsible people to undertake the duties of Honorary Shire Rangers. Michael Corpus (Micklo), Richard Hunter, Joseph Roe, Neil McKenzie, Cecilia Djigaween (Cissy) and Frans Hoogland.*

### COMMENT

We understand that the state legislation administered and enforced by the Shire Rangers include the following:

- Local Government Act 1995
- Local Government Miscellaneous provisions Act 1960
- Dog act 1976 & Regulations
- Litter Act 1979 & regulations
- Caravan Parks and Camping Grounds Act 1995 and Regulations 1997
- Bush Fires Act 1954 & Regulations

Rubibi seeks information (and support) from the Shire to identify the relevant roles and responsibilities that the proposed Honorary Rangers could or may wish to undertake under delegated authority. Rubibi requests clear concise information from the Shire on the implications of these various responsibilities under the Acts, and the process for appointing Honorary Rangers.

We would also like to ascertain the possibility for training that may be needed. Then together with the Shire the proposed Honorary Rangers would identify those relevant responsibilities and duties they will undertake.

Responsibilities carried out by Honorary Rangers would assist the Shire Rangers in their duties. It will also provide a formal recognition of this positive management strategy being undertaken by Traditional Owners and custodians and Minyirr Park work teams.

## **OFFICER COMMENT**

Persons may be appointed under certain Statutes as indicated below.

***Any authorisation made may be limited to certain areas of operation and/or to the authority to exercise some or all of the powers conferred by the Acts. In other words the nominated individuals may be appointed to exercise the authority of the position to an extent that the Shire sees fit.***

In all cases an official notification of appointment signed by the CEO is to be issued to appointed officers however, Part XX of the Local Government (Miscellaneous Provisions) Act stipulates that this authorisation must be Gazetted.

Appointed persons may be called by the generic names of “Ranger” or “Honorary Ranger” however their appointment and identification would refer to the appointed name under the Statute as indicated below.

It is noteworthy that an honorary warden, under the Aboriginal Heritage Act 1972 may also be an Authorised Person under the Control of Vehicles (Off Road Areas) Act by means of their appointment. I understand that Rubibi is currently investigating the appointment of honorary warden.

## **CONSULTATION**

Honorary Rangers have been the subject of Shire/Rubibi ongoing discussion since 1996. In 2005 the Shire requested Rubibi to submit names for consideration.

## 5.2 ADDRESSING ILLEGAL ACCESS AND RUBBISH DUMPING

**SUMMARY:** Rubibi seeks Shire support to help block off illegal vehicle access and remove rubbish in and adjacent to the coastal park and the environmental cultural corridor.

### BACKGROUND

There are more than 6 illegal vehicle entry points within the environmental cultural corridor, linked to the coastal park's Reserve 43080 and 19289. This has encouraged the dumping of household refuse, weeds and garden waste, along with oil and car and machinery eg fridges. The area is being used as an illegal tip site.

Minyirr Park work teams currently clean up what they can in the area, but seek Shire support to assist, particularly with rubbish removal and blocking off access. Big pylons from the Port have previously been used to block vehicle access and this has worked well in many instances.

### COMMENT

Rubibi would like an on-site meeting with relevant Shire staff who could ascertain the Shire plant and staff requirements needed to assist Minyirr work teams, and agree on how and when the work could be undertaken.

This would form part of the Minyirr Park work plans for 2006-2007.

### OFFICER COMMENT

The Environmental Cultural Corridor (ECC), is the area in between the Januburu subdivisions. That land is not under the control of the Shire, it is still UCL and now has native title over it. Landcorp have put a proposal to the Shire on its future management options and the Shire have responded. The ECC is not part of Reserve 43080 or Reserve19289 and therefore is not the subject of the Committee.

### 5.3 COASTAL PARK VISITOR ACCESS and PROMOTING TRANSPORT LINKS

**SUMMARY:** Managing and improving visitor access to the beach, coastal reserves and integrating transport and pedestrian access links to key areas between Cable Beach and Gantheaume Point (Minyirr) are vital. Rubibi would like to open discussions with the Shire and other stakeholders to advance this objective and to enable strategic planning of access and transport links.

#### BACKGROUND

The Shire of Broome's *Coastal Park Management Plan* recommended integrated planning to link the transport and pedestrian access to the beach, coastal reserves and important tourist and cultural areas around Minyirr Park. It also recommended promoting pedestrian access and provision for people with disabilities and those for whom access is difficult eg young children and the elderly or frail.

Minyirr Park had site plans drafted by Landvision in 2001 in consultation with Traditional Owners and Shire staff, and funded by CoastCare to Rubibi. This draft was to enable discussion amongst stakeholders and to relate priorities to plans and works. The site plans included the identification of possible routes and links for carparks, vehicle access, bike and pedestrian paths, boat trailer parking, horse access and improved visitor facilities like ablutions and interpretation.

Many of these have been successfully established.

The walk trails are developed, shade shelters provided, water supply established at the base camp, car parking developed, the access entry points identified and effectively signed for visitors, and interpretative signage is underway and paths completed at the base camp in Minyirr Park. Funding has been secured for ablutions and this will be developed in 06-07.

#### COMMENT

Rubibi has a number of linked proposals being:

- Develop in stages a multipurpose path, a pedestrian cycleway, linking in with Minyirr Park from the Cable Beach end to Gantheaume Point (Minyirr), and to the adjacent car parks, road access and beach entry points.

- Consider a visitor loop or 'cultural heritage' trail concept along with the pedestrian/bicycle path from Minyirr Park to the top tourism icons of Cable Beach and Gantheaume Point and Dubbadubbagoon (base camp at Minyirr).
- Establish a bus stop on Gubinge Road at the entry point to the Minyirr Park base camp, and encourage the bus service to consider the increased provision of services along Gubinge Road to and from Gantheaume Point.

The request here is to seek funding opportunities to undertake planning and to implement the development of pedestrian/cycle ways in stages. Funding is available, for example, through the LotteryWest Trails Grant Program where applications close in March.

Rubibi believes that planned pedestrian access integrated with public transport availability will offer residents and visitors the opportunity to come by public transport, by bicycle or on foot to coastal park and high use visitor areas around the coast. This will reduce the pressure on car parking, pressure on cultural heritage areas, and reduce vehicles on the beach.

By promoting public transport use and pedestrian access it will in turn improve the amenity of the coastal areas, and add value to the health and well being of people by encouraging physical activity.

An integrated long-term plan to link transport here has the potential to reduce Shire expenditure on carparks and enforcement eg vehicles on beach, illegal parking, and congestion during events like race days and concerts. It will improve the safety on roads, by encouraging bikes and pedestrians (and joggers) to use the path. The proposed pedestrian and bike path would enable those with small children in strollers, the older population and those people with disabilities to have safer and greater access to the highly valued coastal environs.

With a well planned, well maintained and effectively marketed approach to moving people around by public transport and on foot, in high use tourist areas and away from fragile and sensitive natural and cultural areas, it will be a sustainable and long term strategy that will be an advantage for all stakeholders.

## **CONSULTATION**

Initial contact has been made with Scott McDougall owner of Broome Bus Lines, to ascertain the process for locating bus stops.

Currently the 7am town bus service extends to Gantheaume Point throughout the year, except on Sundays during the Wet. It goes past the Minyirr Park entry at about 8am. The business promotes the service as a "*Great for an early morning walk back along Cable Beach (approximately 5kms).*"

Rubibi is keen to see a bus stop established at the entry to the base camp, to encourage visitors to use public transport, and to provide a means of transport for the Minyirr Park workers commencing duties in the morning.

Scott has advised that extending the bus service must be a profitable routing, and expressed support by offering to drop passengers at the Park entry on the early morning service. Minyirr Park staff will write to Mr McDougall seeking support for a bus stop at the base camp entry point.

## **OFFICER COMMENT**

The above items require funding and some have been included as part of the current Native Title negotiations. A range of items are scheduled in the Shire's forward programs including path links and car parks.
