SUMMARY: Minyirr Park requires confirmation that the Shire will provide the annual grant of \$129,361.10 as Project Coordinator Kandy Curran and Minyirr Park Administration Project Officer Kerry Marvell are resigning from their positions and assurance of funding is required before the positions can be advertised.

BACKGROUND

Minyirr Park is an important joint arrangement between Aboriginal Traditional Owners and the Shire of Broome. The three main goals are to:

- Conserve the environmental integrity of the coastal areas;
- Protect and promote Aboriginal culture and heritage; and
- Provide opportunities for people to recreate, in a manner compatible with the conservation and cultural and heritage values held for the Park.

Minyirr Park requires assurance that the Shire will provide wages needed for staff for 2008/09 financial year in the annual Shire Grant. With native title negotiations not yet complete and two administration jobs needing to be advertised to continue the running of Minyirr Park, it is imperative that Minyirr Park has assurance of continued Shire funding so the jobs can be advertised. The cost of wages for two full-time on ground supervisors, 1 project coordinator and one administrative assistant required to run Minyirr Park for 2008/09 is \$290,783. Minyirr Park seeks Shire commitment to provide assurance that an annual grant of \$290,783 will be offered once again to Minyirr Park.

Financial contribution to the Coastal Park Management Committee will be included for consideration as part of Council's 20078/09 budget deliberations. Details of support of this ongoing financial contribution from this Committee will be provided to Council.

SUMMARY: Rubibi requests a discussion with the Shire on vehicle management planning on the Broome Peninsula.

BACKGROUND

Rubibi understands that the Shire has received a report from the Cable Beach Motor Vehicle Management Committee. With Minyirr Park Reserves 19289, 43080 and 36477 including Cable Beach to the high tide water mark, it is important to discuss motor vehicle management planning for Cable Beach.

The management issue of unregulated vehicle access to Cable Beach has been raised as an Agenda item by Rubibi on many occasions. In addition, the On-Site Supervisors for the Minyirr Park Project have liaised directly with relevant Shire staff on this issue. Unregulated vehicle access to the Beach has detrimental affects on cultural heritage and environmental values of the Beach.

Minyirr Park is a joint land-management project of the Shire of Broome and Rubibi. The project arises from the 1999 *Coastal Park Management Plan* (commissioned by the Shire of Broome) and is now in its ninth year of implementation).

COMMENT

It should be noted in Council's consideration of this issue, that Rubibi is not merely another "stakeholder" in public consultations, but rather a management 'partner' with the Shire. This partnership has been the basis for the successful Minyirr Park project. In keeping with this partnership, Rubibi looks forward to a collaborative approach to planning aimed at addressing this serious coastal management issue.

OFFICER COMMENT

The work of the CBMVM was completed some time ago and a position paper has been prepared that takes into consideration work that has been undertaken by the CBMVMC and a formal report will be presented to Council's July Ordinary Council Meeting for consideration.

CONSULTATION

Public consultation on management options should only take place after:

- (i) The Shire and Rubibi have jointly identified management options to address the issue of vehicle access to Cable Beach; and
- (ii) The options so identified have been submitted to Council through the Coastal Park Management Committee.
