1. Welcome and apologies

1.1. Opening and welcome:

1.4. HW- Presentation on drainage swale and outlet plans LDPD2

HW presented on drainage proposal for Broome North which will drain under Broome Highway and into part of the In Town Conservation Estate adjacent to Dampier Creek. The proposal requires approval from both the Shire and Yawuru.

2. Minutes of previous meeting

2.1. Review and adoption of September 2013 minutes:

JB amendment required page 6 of the minutes, section 3.1 to read “by consensus”.

2.2. Actions arising:

Action item 3 (11-9-13): MD handed out Broome Advertiser standard advertising rates. GC stated that the Shire do get significant discounts through WALGA and the YPC could utilise these discounts.

MD- Regular items can also attract significant discounts.

GC- Stated that the Broome Advertiser had contacted him in reference to issues associated with off road vehicles (ORV).

GC- The Yawuru Ranger team and Shire Rangers carried out a collaborative patrol on Sunday 10th November focusing on ORV issues. This should be reported in the paid advertorial.

DS the advertorial is still being worked up by the DPaW team. The shire has provided a draft article relating to ORV's.

DS DPaW staff have met with Shire ranger services staff to discuss coordinated patrols, newspaper advertorial and signage/ barrier plan in the Cable Beach-Coconut Wells area.

JB- Option is available to use the “Rangers are now targeting” sign on the Old Broome Rd to display Off Road Vehicles/ motorbikes/ unlicensed vehicles or similar.

JB- Requested the development of a one pager outlining a process to have YPC media published including development of articles, approvals required and deadlines requiring to be met.

ACTION- DPaW to develop (with assistance from the YPCWG) guidelines for YPC publications and distribute to all parties.

BT requested clarity from YPC on regularity of the YPC Advertorial. General discussion around time frames. Agreement was reached that the YPC would include advertorials in the Broome Advertiser on a quarterly basis.

Action Item 4 (15-5-13) JM informed that there are 3 draft names for the management plans but final names will be decided after outcome of marine park planning works (potential extension of Marine Park over Roebuck Bay Intertidal Areas).

Action item 8 (11-09-2013)- JM updated on progress, the issue will be dealt with on a number of levels- The Yawuru PBC will be writing to Mr Morrell in relation to the native title that exists in the area, a letter will be written from the Rubibi/Goolarabooloo referring to a previous agreement with Mr Morrell restricting activities in this area, proposed to send a letter from the YPC (Shire/ Yawuru) also requesting removal of property. JM tabled a draft letter for consideration.

GC- requested further time to consider the letter and the shire's appropriate response.

ACTION- Shire to consider letter and shire's position on further action as soon as possible.

Action item 2 (10-07-2013) Port Excision- JM noted that there had only been one preliminary discussion at a YPCWG level and there was expectation that there would be further discussion amongst the 3 partners before going to Shire Council for resolution. JM stated that Yawuru felt all options for management had not been properly explored prior to shire council reaching a resolution. JM stated that Yawuru are not in support of the process followed by Shire and also resolutions reached by the Shire Council.

GC stated that the YPC were not driving this process for Shire as the Dept of Lands had requested a Shire Council position and this is what had been reached at the October Shire Council Meeting. Clarification is required on the process from here and where this sits in relation to the potential changes to the Marine Park boundary.

AB- stated that on the 27th November a meeting would be convened by the Dept of Premier and Cabinet to progress this further.

GC stated that there is also a dispute resolution process set out in the ILUA that may be able to be used to work through this.

JM stated that this should be a last resort and preference is to investigate this further, gather together all options and work through a process to come up with the best solution.

P.D. suggested that the next step to progress these discussions is the meeting with the DPC to be held on the 27th Nov.

ACTION- All parties to attend meeting on the 27th Nov with DPC.

3. Matters across all tenure

3.1. Proposed meeting dates 2014:

AB ran through some justifications for meeting every three months- allow more time between meetings to achieve progress on action items, to reduce time spent on administrative tasks relating to park council, initially meetings were held every two months to ensure management planning was being sufficiently serviced and works approved- requirements here have reduced as management plans are now in a draft format and once final management plans are in place works programs should just roll out.

JM supported motion and suggested that special park council meetings could be called if required sooner.

JB- against-stated that the YPC meetings should be every 2 months as there are some big items coming up for YPC consideration such as end of initial funding arrangements, roll out of management plans and how to progress YPC requirements into the future.

GC stated that in the early part of 2013 meetings should be held every 2 months and reassess in the later part of the year.

AB agreed with GC.

Consensus that meeting dates for February, April, June will stand and reassess further dates at the June meeting.

3.2. Off Road Vehicles

Consensus that this has been covered in action items above.

4. Town Site areas (Yawuru, Shire)

4.1. Town Site Management Plan Update.

MD- stated that Shire has been working through the In Town Mgt Plan by holding workshops with Shire officers. Workshops had primarily to date focused on the Service Provider Agreement which was close to being completed from a shire perspective.

JM- Yawuru are also still working through the latest consolidated document and at the YPCWG level had agreed to complete the internal processes prior to the February YPC meeting.

5. Cable Beach intertidal zone (Yawuru, DPAW, Shire)

GC-Commended DPaW on the Cable Beach Volunteer Turtle Monitoring Program but requested that DPaW communicate these types of In Town projects with the Shire.

6. Out of Town and Roebuck Bay area's (Yawuru, DPAW)

6.1. Proposed extension of Yawuru Nagula Roebuck Bay Marine Park

PD- Stated that the discussion above has covered much of this topic.

DS- Introduced briefing note outlining a process for Yawuru and the State to consider extending the Marine Park across the Roebuck Bay Intertidal areas (as seen in the ILUA).

JM- Stated that this is an investigative process allowing for consultation and negotiation between Yawuru and the State to determine whether the marine park extension over the Roebuck Bay Intertidal Conservation Estate is a satisfactory outcome.

GC stated that provided this process is only working on the areas as they currently stand in the ILUA then the shire has no concerns. However if the process moves into the Port Intertidal areas then the shire does have an interest and will be involved.

GC- adds to resolution “for lands/ waters as currently set out in the ILUA”. –

7. Reports and Operational matters (Yawuru, DPAW, Shire)

7.1. Financial summary

AB presented financial summary in briefing note format. All monies have now been paid into the Yawuru Trust Account as set out in the ILUA.

PD asked that for the February meeting some more detailed background information be provided on expenditure from previous years to assist with preparation of future budget requirements. Can see the February meeting being quite focused on budget and ways forward to secure ongoing recurrent funding.

GC- queried whether the marine parks would be funded separately.

AB- There has been dialogue with DPC regarding ongoing funding for the Yawuru Conservation Estate. The marine park will have its own cabinet submission and budget. There has also been discussion around ongoing, recurrent funding for the Yawuru Conversation Parks being wrapped up in this process and having a separate cabinet submission.

7.2. Operational Report / presentation

JR presented an operational report giving an overview of the Ranger team’s operational works since the last meeting. Main items-

- Patrols
- Commencement of trail pad install on the Wandanyjirr Trail within Minyirr Park
- Weed control
- Crocodile management issues close to town
- Highly successful October school holiday
- Visitor risk management leading to closure of one car park in the Crab Creek area.
- Involvement in migratory bird research projects
- Cable Beach turtle monitoring
- Lyngbya surveys
- Attendance at wildfire situations across the Kimberley.
- Ongoing training.

8. Other matters and correspondence in

8.1. Area 16 redundant road reserve closure, update on progress from Shire

PD stated that vesting of Area 16 (Out of Town Conservation Estate between Buckley’s Plains and Willie Creek) had not occurred as there were some outstanding issues with shire road reserves.

JB the Shire's resolution from October 2012 was "Council advises the YPC that it does not support this proposal in its current form but would be prepared to consider initiating the necessary formal processes for a proposal incorporating the following elements

1. All redundant road reserves including portion of the Broome-Cape Leveque Road and a portion of road number 6863 south of McGuigan Rd are included in the closure process
2. A dedicated road reserve is created for the Broome-Cape Leveque Road; and,
3. Dedicated road reserves created to the yet to be determined key recreation sites with access to the tripartite intertidal areas of Willie Creek and Cable Beach.

JM stated that the State is not proceeding with creating the reserves until the road issues are dealt with. The CALM Act cannot then be implemented on this area. Preference is that the road issues are sorted and Area 16 comes across as a complete reserve now without holes within.

JM is there a process that can be put in place to re-visit this issue.

AB- Once vested the lands are removed from Shire control so there is no requirement for Shire road reserves to be put in place (as per pt 3 in council resolution above).
