Membership Terms and Conditions

- Access cards and Multi-Visit passes are not transferable.
- Access to Squash courts and tennis courts limited to 1 court per hour during peak time and subject to availability. Partners/friends playing with Access Card holder pays \$10.00.
- Appropriate attire must be worn while in the facility
- For your safety, members and guests are required to follow the directions of centre staff and signage
- 12 month memberships are entitled to one suspension of no longer than one month during the term of the membership at no charge. Suspension requests are to be made in writing addressed to the Centre Manager. Suspensions are to be made in advance and will not be backdated.
- Child and Senior memberships are available on presentation of appropriate identification
- It is a condition of this membership that you will advise of any changes to your medical condition.
- Refunds for 12 month memberships will only be considered for medical reasons and must be supported by a doctor's certificate. Refunds incur an administration fee of \$50.
- Payment methods accepted are cash, eftpos or credit card. We do not accept Amex or Diners.
- This agreement is subject to a 48 hour cooling off period which commences at the point of sale. During the cooling off period you may terminate your membership upon written request addressed to the Centre Manager if required. (Charges will be applied for any sessions already undertaken)
- All refunds will be submitted to the Shire of Broome for processing and a cheque will be issued to the client via post.
