## Fees Payable

For new dog registrations received after 31 May and before 1 November, the fee payable is 50% of the fee that would otherwise be payable. Dog registration expires on 31 October of that year, depending on registration selected.

**Pensioner concessions** can only be applied on presentation of a current Pensioner Concession Card, State Concession Card, Veteran's Card or a Senior's Card together with a Commonwealth Senior's Health Card.

**Sterilised fees** will apply upon presentation of either of the following:

- Veterinary Surgeon's Certificate of Sterilisation;
- Signed Statutory Declaration; or
- Shire authorised officer confirming sterilisation.

The fee payable for registration of a **Declared Dangerous Dog, Restricted Breed Dog or Commercial Security Dog** is \$50.00. Concessions do not apply to these fees and registration **MUST** be renewed annually.

The fee payable for registration of a **Working Dog** (a dog that is *bona fide* used in the droving or tending of stock) is 25% of the fee that would otherwise be payable.

## CONDITIONS

1. Dog owners are reminded that dogs three (3) months and over **MUST** be registered. The Shire also requests that dog owners inform the Shire immediately of any change in ownership, the death of a dog or change in address. Failure to register a dog may result in \$5000.00 penalty under the *Dog Act 1976*.
2. Dogs three (3) months and over must be microchipped (unless exempt) and wear their registration tag at all times.
3. The maximum number of dogs to be kept on any premises is two (2) over the age of three (3) months (dispensation can be given to keep more than two (2) dogs in some cases, but subject to a written request to the Shire and certain conditions being met).
4. To register a dog under sterilised concessional rates, an owner or agent should either have a veterinarian's certificate or be prepared to sign a statutory declaration to that effect. Pro rata refunds can be made where licensed dogs become sterilised *Dog regulations 2013 R.19*
5. Dog owners must have means exist on their premises at which the dog will ordinarily be kept for effectively confining the dog within those premises. Means for effectively confining the dog within the premises does not include tethering.
6. The Shire of Broome offers Broome residents with a Valid concession card, half price cat/dog sterilisation (conditions apply) for more information enquire or apply for the cat/dog sterilisation subsidy through the Shire.
