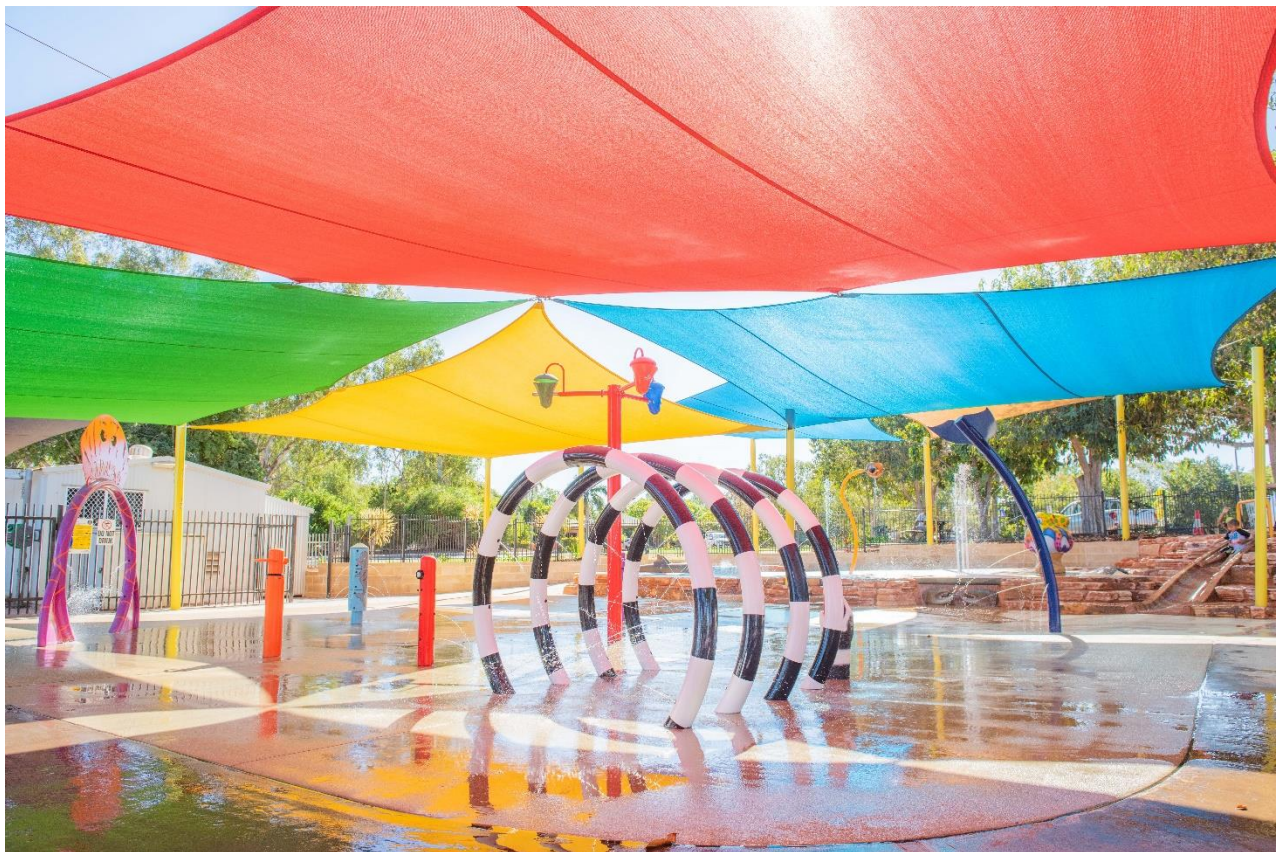


Early Rates Incentive Prize

Rates Prize Draw Terms and Conditions 21/2022

1. This competition is a promotion run by the Shire of Broome ("Promoter").
2. Entries and information on prizes and how to enter form part of these Terms and Conditions.
3. Participation in this competition constitutes acceptance of these Terms and Conditions.
4. The competition is open to ratepayers of the Shire of Broome who pay the full amount due as listed on their 2021/2022 rates notice before 2pm WST Tuesday 19 August 2021 for electronic payments and 4pm WST for payments made at the Shire office or Ratepayers who have no outstanding overdue rates and service charges, including accounts with credit balances.
5. Payment must be received before the closing date to go into the draw. No responsibility is accepted for late, lost or misdirected payments.
6. The competition commences 15 July 2021 and closes 4pm WST Thursday 19 August 2021. The competition will be drawn at 3:00pm WST Monday the 23 August 2021 in Council Offices, Cnr Weld Haas Street, Broome WA 6725.
7. All winners will be chosen at random from a database of all eligible rate payments received. The winners will be randomly matched to a prize package. The Promoter's decision is final.
8. The winners will be notified by phone, email or mail and sent a formal invitation to attend the Council Meeting where they will be announced as the winner of the Prizes and presented with their prize in the form of a Cheque. If unable to attend the Council Meeting the winners can come to Broome Council Offices at their convenience to collect their prize from the Rates Team in the form of a cheque. If the winner does not reside in Broome the cheque will be posted to their nominated postal address. Competition results will be published on Council's website following the draw.
