Written support from the Shire is a prerequisite to obtaining a Permit from MRWA, but it remains a decision of MRWA as to whether a permit will be issued.

CONDITIONS ON SUPPORT OF MRWA PERMIT TO OPERATE RESTRICTED ACCESS VEHICLE IN EXCESS OF NETWORK LEVEL



- Final approval to travel is subject to MRWA permit being issued. A copy of the MRWA permit is to be forwarded to the Shire of Broome or a copy of any addendums.
- Cape Leveque Road is RAV 2 Network Road. Refer to MRWA for applicable vehicles
- It is the responsibility of applicants to ensure that each vehicle travelling meets the respective RAV network requirements
- Road Train trip requests to be considered on their merits and be subject to appropriate conditions;
- Only one (1) of the above vehicles is allowed to be on the section of road at any one time.
- No responsibility will be taken by the Shire to recover any bogged or disabled vehicles, and any extraordinary damage caused by any heavy vehicle may be chargeable to the operator, depending on circumstances at the time.
- Wherever undue stripping of seal aggregate or edge breakage occurs as a result of the turning/screwing action of the road trains entering or leaving a road, surface repairs deemed necessary to maintain the road in reasonable condition shall be at the applicants cost;
- The applicant shall indemnify and keep indemnified the Shire of Broome and all their respective agents, officers, members and employees from and against all claims, demands, suits, proceedings, actions, causes of action, liabilities, losses and damage sustained, suffered or incurred by the applicant whilst travelling on the designated route.
- This Shire support for a permit may be cancelled at any time at the discretion of the CEO, if circumstances warrant.
- The permit holder will be notified in writing of any altered date of commencement or completion of the road closure or restricted access permit.
