## Broome North SP2 LWMS Addendum

This letter has been prepared to support the submission of the Broome North Structure Plan Stage 2 Amendment No 1.

The Broome North Structure Plan Stage 2 Local Water Management Strategy Rev 1 (LWMS) (GHD December 2016) was prepared to outline the water management principles and objectives for the structure plan area and describes the key strategies for water conservation, water quantity management and water quality management. The key strategies have been progressively refined for the local conditions during development and planning for the Broome North LDP1 and LDP3 areas, and in consultation with the Shire of Broome, Department of Water and Environmental Regulation, and Yawuru. The Broome North Structure Plan Stage 2 LWMS Rev 1 (GHD December 2016) was endorsed by the former Department of Water on 11/01/2017.

The Broome North Structure Plan Stage 2 LWMS was prepared with reference to Broome North Structure Plan – Stage 2 Drawing RD1 200 Rev D (Attachment 1). Comment received from the Shire of Broome have resulted in minor amendment to the Structure Plan layout as shown in Broome North Structure Plan – Stage 2 Drawing RD1 200 Rev E (Attachment 2). A comparison between Rev D and Rev E of the Broome North Structure Plan Amendment 1 is provided is Table 1.

## Table 1 Comparison of Structure Plan Amendment 1 Rev D and Rev E

Comparison between Rev D and Rev E identifies that the development area and lot yield have marginally decreased, while the POS provision and dedicated drainage reserves have remained similar. The minor amendment to the Structure Plan between Rev D and Rev E results in no substantive changes to the LWMS strategies for water conservation, water quantity management and water quality management, and as such no changes are proposed to the Broome North Structure Plan Stage 2 LWMS Rev 1 (GHD December 2016) to support resubmission of Broome North Structure Plan Stage 2 Amendment No 1.
